



APTC Reasonable Explanation

Annual household income for the Advance Premium Tax Credit (APTC) can now be verified using a Reasonable Explanation. This is to help those who have not filed taxes or are unable to verify income using other acceptable documents. Remember that APTC income is what the household's total taxable income will be the current year. This may be different from past years.

This only pertains to APTC income verification and cannot be used for Medicaid and other programs. Below are the steps with screenshots attached.

Navigate to the Document Center. Here you will see if a case is pending for APTC Income Verification. If the case is pending, click on the "Upload Documents" button. Note: This screen should show File Needed for APTC Income Verification to use this.
