

Since October 15, Agents, kynectors, and Residents may view Plan Year 2024 Qualified Health Plans (QHPs) using the <u>Prescreening Tool</u> within kynect.

## **Extension of Child Medicaid Eligibility**

Children under the age of 19 as of October 1, 2023 will have an automatic extension of their Medicaid eligibility for 12 months from their renewal due date, for renewals starting October 1, 2023 until April 30, 2024.

Example: Laura is 16 years-old with a renewal date of November 1, 2023. Laura will have an automatic extension of Medicaid eligibility that will extend until November 1, 2024.

## **Open Enrollment Toolkit**

The Open Enrollment Toolkit for Plan Year 2024 includes a number of graphics that illustrate how to find local help for health coverage, Open Enrollment dates, Open Enrollment reminders, Medicaid annual renewals, Open Enrollment Frequently Asked Questions (FAQs), and an Open Enrollment brochure. Four table-top signs are available that communicate how to keep Medicaid benefits up to date, promote enrolling/renewing/changing a QHP, provide information on presumptive eligibility, and detail how to get in contact with free local assistance.

### **New Releases**

As of October 27, 2023, the following updates will be deployed as part of Release 23.10:

- Find a kynector/Find an Agent Search Enhancement The Find a kynector and Find an Agent search tools will be enhanced to show the location of Agents, kynectors, or organizations on Google Maps based on proximity.
- Enrollment Manager Module (EMM) and Shopping Experience There have been enhancements added to the shopping portal that allow Agents and kynectors to retain plans in a shopping cart and return at a later time.
- **kynect Page Instrumentation Metrics** An improvement is being deployed to address kynect screen slowness and will include a reporting and tracking mechanism to review future incidents.
