

# KENTUCKY MEDICAID UNWINDING DEMOGRAPHIC REPORT

October 2025

#### **INTRODUCTION**

The Kentucky Department for Medicaid Services (DMS) wants to make sure that all eligible Medicaid beneficiaries keep their coverage as they go through their regular annual renewals. Medicaid renewals are the processes states use to regularly make sure that individuals still meet the eligibility requirements for Medicaid benefits each year. This means that all Medicaid and KCHIP members undergo a redetermination of their eligibility every 12 months. Those who are determined to be eligible will continue to receive Medicaid coverage. Those who are determined to be ineligible for coverage will be removed from Medicaid and connected to alternative coverage options in the state.

This report dives deeper into the demographic breakdowns of Kentucky Medicaid renewals, pending, and terminated in October 2025.

#### **SNAPSHOT**


A total of 97,941 individuals who had their renewal due on October 31 were determined eligible for renewed coverage. 19,391 total individuals had their coverage terminated as of October 31. 5,100 of those individuals were determined ineligible based on eligibility requirements and have been terminated. For individuals who were terminated on October 31 and have supplied requested information for eligibility determination, 537 renewals have been reinstated as of the finalization of this report.

Note: DMS is unable to track enrollment in coverage outside the state of Kentucky. For example, a significant number of individuals are estimated to have gained health coverage through an employer, meaning that individuals who do not come back to renew should not be assumed to be uninsured.









#### Approvals Breakdown

- <u>87,161</u> were renewed on an *ex parte* basis
- 10,780 were approved through completing a pre-populated form

## Terminations Breakdown

- <u>5,100</u> were determined ineligible for Medicaid
- 14,291 were terminated for procedural reasons (i.e., failure to respond)

#### Pending Cases Breakdown

- 1,891 Continuous Coverage Children extended as part of issue tracked post business approvals.
- 903 pending for document processing
