



# KENTUCKY MEDICAID UNWINDING DEMOGRAPHIC REPORT

*January 2025*

## INTRODUCTION

---

During the COVID-19 Public Health Emergency (PHE) the Kentucky Department for Medicaid Services (DMS) made sure that all Medicaid beneficiaries kept their coverage and paused all annual renewals. At this time, DMS has returned to normal activities and resumed conducting annual renewals for Medicaid members. This means that all Medicaid and KCHIP members undergo a redetermination of their eligibility every 12 months. Those who are determined to be eligible will continue to receive Medicaid coverage. Those who are determined to be ineligible for coverage will be removed from Medicaid and connected to alternative coverage options in the state.

This report dives deeper into the demographic breakdowns of Kentucky Medicaid renewals, pending, and terminated in January 2025.

## SNAPSHOT

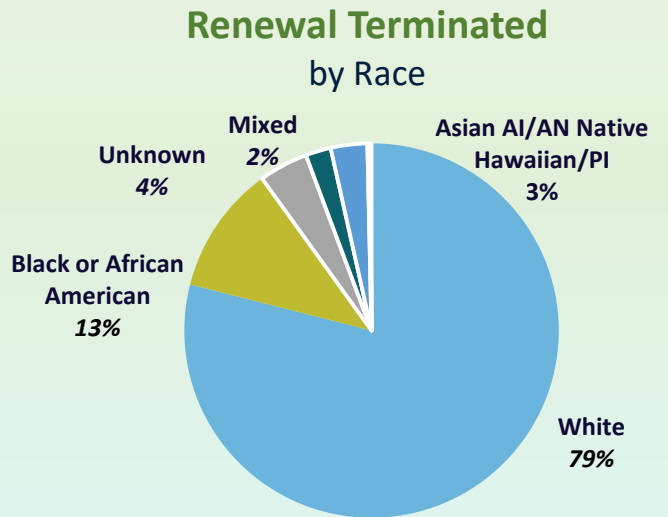
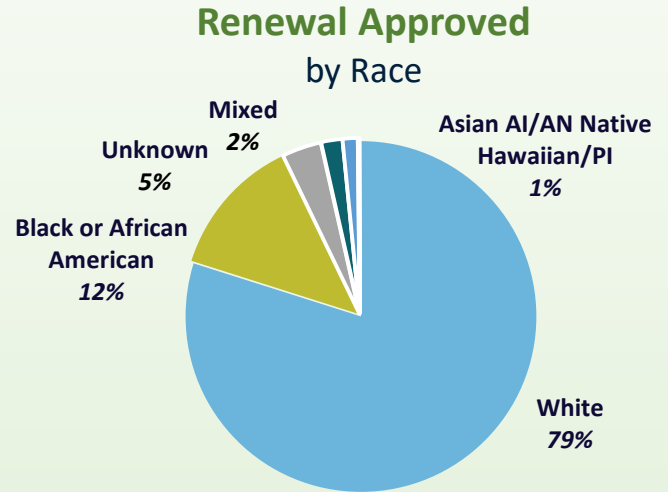
A total of 61,288 individuals who had their renewal due on January 30 were determined eligible for renewed coverage. 1,945 total individuals had their coverage terminated as of January 30. 1,927 of those individuals were determined ineligible based on eligibility requirements and have been terminated. For individuals who were terminated on January 31 and have supplied requested information for eligibility determination, 134 renewals have been reinstated as of the finalization of this report.

Note: DMS is unable to track enrollment in coverage outside the state of Kentucky. For example, a significant number of individuals are estimated to have gained health coverage through an employer, meaning that individuals who do not come back to renew should not be assumed to be uninsured.

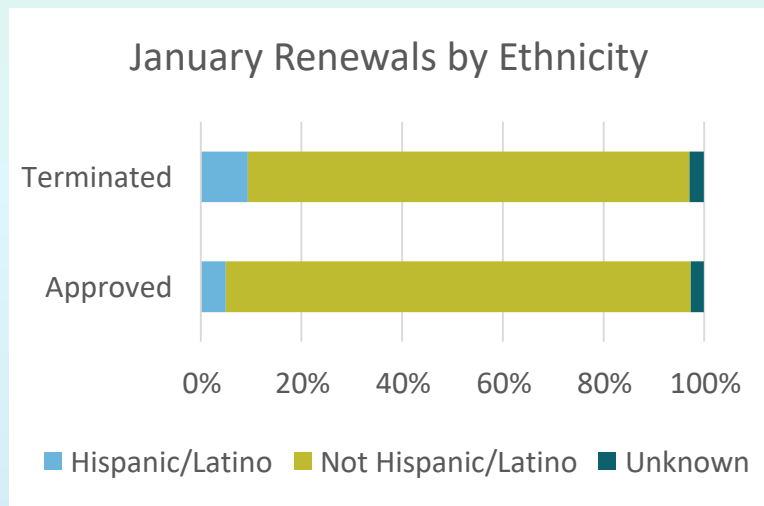

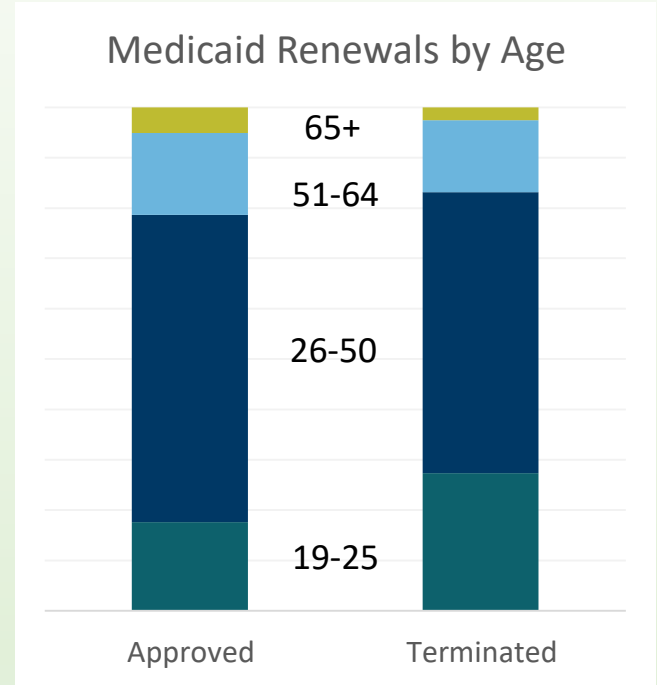

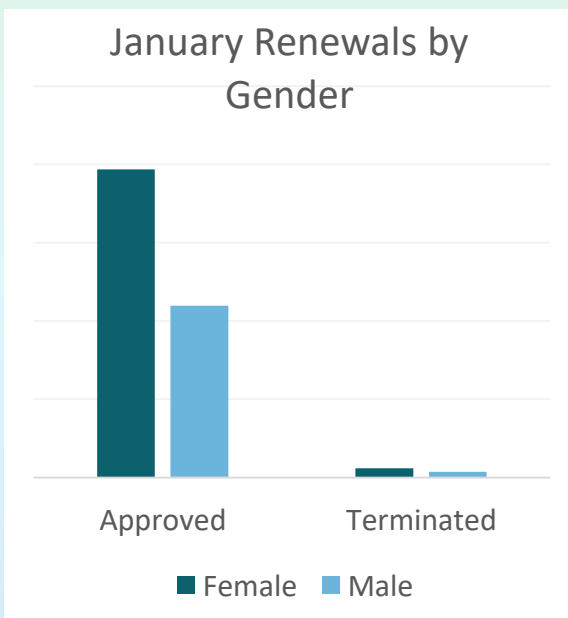

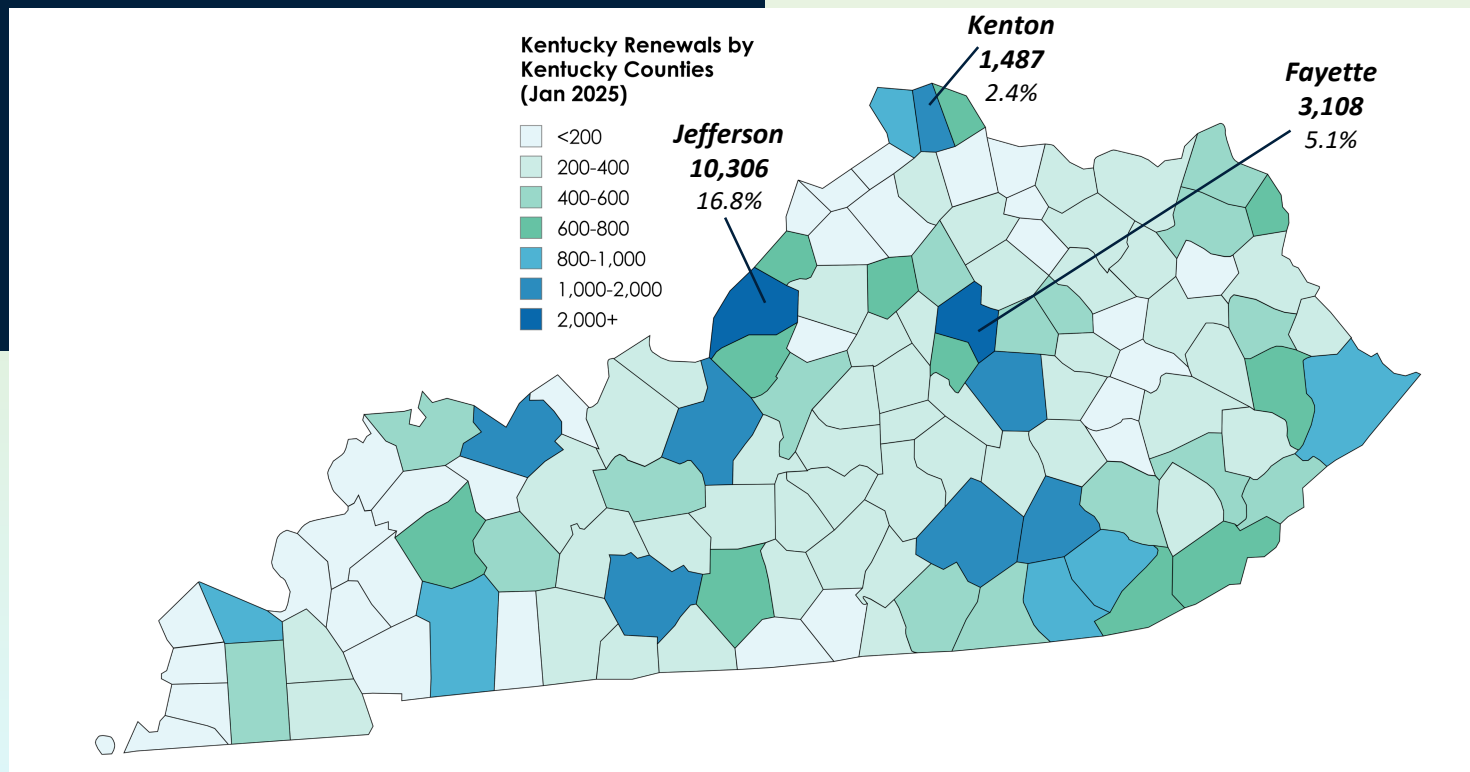

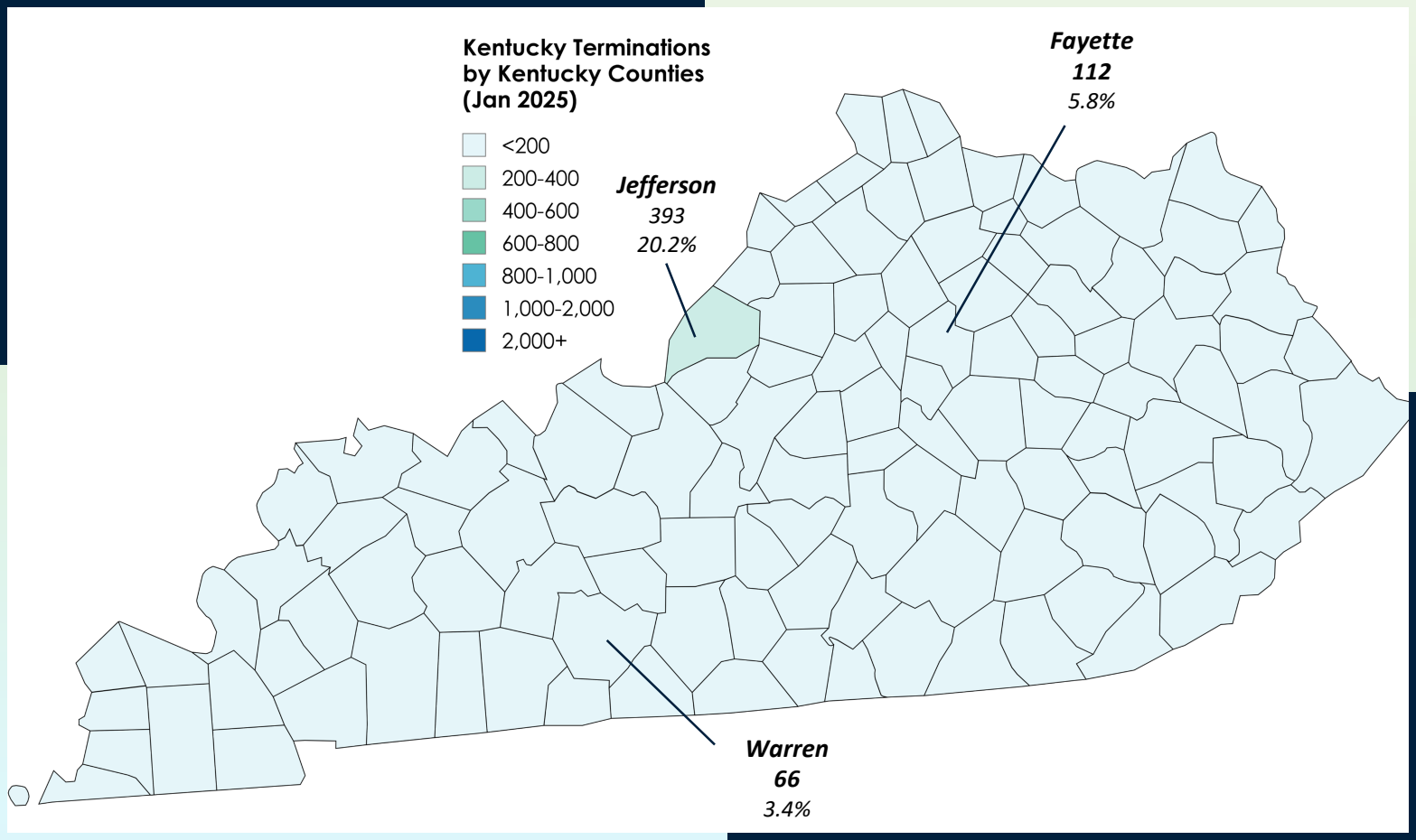

# CMS MONTHLY REPORT DATA

Additional metrics are included in the monthly report to CMS. The following table highlights key information regarding the renewals due during the January Reporting Period. The full report can be accessed at <https://medicaidunwinding.ky.gov>.

## Approvals Breakdown

- 55,609 were renewed on an *ex parte* basis
- 5,679 were approved through completing a pre-populated form

## Terminations Breakdown

- 1,927 were determined ineligible for Medicaid
- 18 were terminated for procedural reasons (i.e., failure to respond)

## Pending Cases Breakdown

- 7,502 were extended due to flexibilities and strategies
- 1 case is pending document processing
