

# KENTUCKY MEDICAID UNWINDING DEMOGRAPHIC REPORT

November 2024

#### **INTRODUCTION**

During the COVID-19 Public Health Emergency (PHE) the Kentucky Department for Medicaid Services (DMS) made sure that all Medicaid beneficiaries kept their coverage and paused all annual renewals. But DMS has resumed annual renewals for Medicaid members. All Medicaid and KCHIP members are undergoing a renewal of their eligibility for coverage since Kentucky resumed annual renewals starting in April 2023 for Medicaid members with a renewal date of May 31, 2023. These renewals will be spread out over 12 months. Those who are determined to be eligible will continue to receive Medicaid coverage. Those who are determined to be ineligible for coverage will be removed from Medicaid and connected to alternative coverage options in the state.

This report dives deeper into the demographic breakdowns of Kentucky Medicaid renewals, pending, and terminated in November 2024.

#### **SNAPSHOT**


A total of 30,194 individuals who had their renewal due on November 30 were determined eligible for renewed coverage. 1,234 total individuals had their coverage terminated as of November 30. 1,167 of those individuals were determined ineligible based on eligibility requirements and have been terminated. For individuals who were terminated on November 30 and have supplied requested information for eligibility determination, 90 renewals have been reinstated as of the finalization of this report.

Note: DMS is unable to track enrollment in coverage outside the state of Kentucky. For example, a significant number of individuals are estimated to have gained health coverage through an employer, meaning that individuals who do not come back to renew should not be assumed to be uninsured.











## CMS MONTHLY REPORT DATA

#### Approvals Breakdown

- <u>22,024</u> were renewed on an *ex parte* basis
- 8,170 were approved through completing a pre-populated form

## Terminations Breakdown

- 1,167 were determined ineligible for Medicaid
- <u>67</u> were terminated for procedural reasons (i.e., failure to respond)

#### Pending Cases Breakdown

- 7,107 were extended due to flexibilities and strategies
- <u>5</u> cases are pending document processing
