

# 2025 Medicaid Federal Poverty Levels For Presumptive Eligibility

Federal Poverty Levels (FPL) are income guidelines issued annually by the Department of Health and Human Services (HHS) to determine financial eligibility for various federal and state assistance programs. Specifically, Medicaid eligibility is calculated based on the household size and monthly income amount.
